- Kara Bilkert is the new shared data position for K Connect. Data and outcomes used to show measurable progress in early childhood in our community.
- Pritzker Children's Initiative: First Steps is applying to hire an Early Childhood fellow, only three will be chosen across the country. This position will be coordinated with the data position. The West Michigan children's???, K Connect, KISD are all working together.
- Millage Presentation: The Millage is officially on the ballot for November. 12 1:30pm before the next GSC meeting there may be a training to help prepare people to support the campaign. Request to share out the news story about the millage being approved. How much of the millage will go to overhead and how much to direct services? \$500,000 for administering when it was a .5 millage. \$1 million for data and dropping down to 500,000 per year. Data is necessary and will cost what it costs initially but then should reduce over time. \$3.5 – \$4 million for direct services and going up over time. \$730,000 is received from the Kent County Prevention Initiative each year. The proposal from the county is that the funding will continue to be given. - 2018/2019 GSC Planning: Fiscal year is ending in September. We have a year between our strategic plans. We will be working on the new strategic plan as well as the action agenda.
