received home visiting. We will be holding a community partner meeting to look at our community's data as well as the survey results to help us measure our readiness to expand home visiting if dollars were made accessible.

- Budget: The budget was sent to group, any questions to Paula. Budget is currently through the third quarter. A large piece of our budget is used for convening families and partners. Meeting virtually has impacted those dollars. We are under where we need to be due to this reality. OGS is aware of this issue and is giving us the freedom to pivot when necessary.
- FY 2021 Guidance: We have not received guidance yet but are being told to assume we will receive the same amount as last year. Workplan for next year is due September 15th. A lot in our work plan were two-year goals so that will be pulled over to this new year. We are required to have at least one goal under each of our four early childhood outcomes. Those goals need to address at least one aspect of the early childhood system. Our workgroups convene to help achieve our outcomes. One of our workgroups is mandated by the state, School Readiness Advisory, with the ISD's GSRP. GSC also needs to partner with GSQ. This is reflected in our workplan. Our workplan must also include parent led strategies. Examples from this year include: Books Blocks and Balls event and Parent Cafes in northern Kent.

• Small Group Activity

Barrier: Creating/maintaining relationships. People are feeling very detached. Action Steps:

- > Drop off incentives (i.e. diapers, playdough, books, resources for parents, etc.)
- Phone calls for those people who do not have the capability to use technology. Helps with that one-on-one connection.
- > Virtual options (zoom, google meets, etc.). Best option to see others.

Framing as a goal: Explore options for bring services to families Increasing innovation to providing services families; creative. Identify opportunities to meet people where they are with services.
